## Consignment Agreement

Then & Again welcomes your quality used furniture, antiques, home décor, accessories and collectibles, as listed on attached sheet. Items must be clean, scent free and in usable condition. We offer cleaning of your items at \$40 per hour with a one-hour minimum. Any items brought in, in need of cleaning, will have cleaning fee deducted from consignor payment.

Commission – The final sale price of consigned items will be distributed between Then & Again and the consignor at a rate of 60% to consignor – 40% retained by Then & Again. Other amounts that may be outstanding such as; cleaning, repair, shipping and handling, and insurance charges will also be deducted from the consignor's proceeds unless otherwise stated.

Pricing – Pricing of all consigned items will be set by Then & Again and Consignor. Prices will be reduced by 15% after 30 days, 25% after 60 days, with final reduction of 50% on day 91. Merchandise not sold after 120 days (4 months) will be reviewed by Then & Again, if item is scheduled for removal it must be picked up by consignor within 7 days or it will become the property of Then & Again. From time to time store-wide sales and promotions will be conducted. All consignment items will be subject to such sales and promos. Then & Again reserves the right to adjust prices at any time as deemed necessary, every attempt to contact consignor, before such adjustment, will be made.

Lay-A-Way – Then & Again shall have the right to sell any item upon a time or deposit basis (lay-a-way). The consignor shall receive his/her share of the sale only after the purchaser has paid the full price to Then & Again. Items put into layaway by clients of Then & Again are NOT considered sold until the final payment is received from the client. Any sums of money on deposit forfeited shall become the sole property of Then & Again.

Liability – Consignor hereby confirms and agrees that in the event of damage or theft of the property, Then & Again's liability shall in no event exceed 50% of the original assigned price. Then & Again will not be held liable for damage or loss not covered by insurance.

Payment – Checks will be mailed by the 5th of each month for the previous month's sold items. Monthly balances of \$10.00 or less will be converted to store credit or combined with following month's payment

Early Removal - Consignor agrees to leave merchandise to be displayed at Then & Again for a minimum of 4 months. Items removed before that time will be subject to a storage/handling fee equal to 20% of original tag price.
